Wisconsin Conservation Congress –

- o Al Shook -
 - Pretty quite. Al has testified on numerous assembly bills, such as AB490 (vets over 70 price break), AB491 (license buying logistics/costs) and AB528 (carcass tags/group bagging with youth hunt accidentally went through and needs legislation to correct), at the Capitol.
 - Working on new guidance document which will allow an alternate to vote.
 - Questions on AB411 it appears no work is being done on it.
 - It appears there is an unfortunate disconnect with some legislators regarding the Congress' role as to whether they can, and should, lobby the legislators when it is in the best interest of the citizens of the state.

Waukesha County CDAC –

- Tom Daluga/Al Shook
 - The Waukesha County CDAC has voted to maintain the herd. It passed. There will also be a holiday hunt (which accounts for 10% of the kill). Last spring, a biologist has determined the herd is being held within 2% of its optimal number. All has recommended that Tom become the chair for the Waukesha County CDAC.
