##### **Conservation Congress**

Bob Wincek gave a report about the Virtual Meeting held for CDAC Chairs and Alternate Chairs on Monday, November 9. Speakers included: Bob Nack, DNR Big Game Section Chief, Preston Cole, DNR Secretary, Dr. Prehn, NRB Chair and Greg Kazmierski, NRB Vice-Chair. Presented Deer Hunt Stakeholder Group with projected goals and objectives for the next 3 years. Bob also talked about the Great Lakes Committee, where they reviewed DNR Resolution #160420, raising Salmon fee from \$10 to \$15. This can only be done by Legislation and the Resolution was forwarded.

### **Conservation Congress con't**

Randy Farchmin reported on the Trout Committee Resolution #600220, Catch and Release of Brook Trout on Nichols Creek in Sheboygan Co. Brown Trout have more than doubled and Brook Trout of declined. Discussion on a catch & release for Brook Trout and removing size limits on Brown Trout. Proposal forwarded to the DNR.

Jeff Hintz unable to make the meeting tonight but sent an email about his Zoom meeting with the Migratory Committee. Reviewed Resolution about the use of shot size "F", but after discussion it failed to pass. There is a UW student that has banded wood ducks with geo locators. If a banded bird recovered please send back info. The WDNR is planning on banding ringneck ducks with geo locators to help understand if population is declining or changed their patterns. Feds may offer 5 Canadian goose for bag limit on the Mississippi flyway (presently set as 3), but the WI biologist feels Wisconsin will remain at 3.

### **Scholarship**

John Riehle received a notice from UW Stevens Point asking if WCCA will continue to offer 2 scholarships. Motion by Kevin Frasier, second by Tom Daluga to continue with the scholarship program. Approved. Al Shook will contact UW Steven's Point .
