Reference below discussion from the June 16, 2021 General Meeting:

\*\*\*\*\*\*\*Discussion on Organizations and Individual Member votes if they are members of WCCA. By-Laws (Article VIII) address voting powers of Organizations and Business Members, but nothing about Individual Membership. Example: If a Member would like to remain a voting member of the WCCA and their Club is no longer a Member, should their voting rights be taken away from them?

Through no fault of their own the Individual Member did not resign from his Club, but his Club left WCCA. This Individual Member is currently active in the WCCA.

WCCA will do nothing further at this time since this matter would have to be an amendment to the current By-Laws. Further discussion or an amendment should be presented at the next General Meeting.

Further discussion held and it was agreed that no member should be left out of the Club or lose their voting privilege or position on the Board of Directors due to their Membership Club no longer wanting to be part of the WCCA or disbands. Motion by Gray, second by Wincek to have an Amendment written to Article VIII of the By-Laws to continue to accept that member. Secretary to write the Amendment and bring to August General Meeting for discussion and/or approval. Approved.
