Secretary's Report

- CDAC seats are assigned. We need someone in the Transportation and DMAP positions.
- Deer numbers for opening weekend of 2023 are 3, 745, up 13% from 2022 opening weekend. Haven't seen any numbers from Youth Hunt or first 5 weeks of deer hunting.

Kids Fishing Clinic (cont'd)

- Gray reports that the WCSFO has 2 upcoming Fishing Clinics for Kids will be Ice Fishing Feb. 17 and Spring Fishing April 13
- WCSFO still has \$8200 in their Treasury. They will spend as much of it as they can before
 having to disburse left overs, in case they do disband. (Thinking of getting Kids Fishing

 money to a 501c3 organization or the Wisconsin DNR. It was suggested they turn money over to

 into creating a Foundation through the WCCA.
